## Keane Bridge, Sylhet

# Mr. BAIDYANAIH MOOKERJEE asked:

\*1. Will Government be pleased to state—

(a) The total cost of the Keane Bridge, Sylhet?
(b) The total collection from the same bridge upto 1944-45, including unrealised instalment, if any, from the present lessee?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN replied:

1. (a)—The total expenditure on original works upto March 1944—Rs. 4,62,749. (b)—Rs. 2,36,050 were realised as receipts from the Keane Bridge and the contiguous town ferries over the Surma river at Sylhet which were auctioned as one unit.

Mr. BAIDYANATH MOOKERJEE: May I know what was the total cost when the bridge was first completed and opened for traffic?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I want notice of

that question.

Mr. BAIDYANATH MOOKERJEE: Was not my question quite clear and how is it that the Hon'ble Minister wants notice for my supplementary question?

The Hon'ble the SPEAKER: When the Hon'ble Minister claims for notice I cannot compel him to answer the question.

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I am sorry, the

figure is not available at the moment.

Babu RABINDRA NATH ADITYA: Are the military vehicles required to pay any toll?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: Probably not.

Srijut ROHINI KUMAR CHAUDHURI: Will Government please let me know if the collection of tolls will be stopped after the entire expenditure is realised?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: That contingency

has not arisen as yet. The matter will be considered later on.

Mr BAIDYÁNATH MOOKERJEE: May I know how much was spent from

the provincial revenues on this account?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I think the money came from the Road Fund.

Babu KAMINI KUMAR SEN: May I know how the recurring cost was

included in the total cost?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I want notice of that question.

Mr. BAIDYANATH MOOKERJEE: Is it a fact that this bridge was built from

the receipts of petrol duties received from the Central Government?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: Yes.

Mr. BAIDYANATH MOOKERJEE: Do Government admit that this is a case of double taxation?

The Hon'ble Khon Bahadur Maulavi SAYIDUR RAHMAN: No.

Mr. BAIDYANATH MOOKERJEE: When this bridge was built from the tax realised on account of petrol duty, the people were already taxed. Then again Government is taxing the people by collecting tolls from them. In that case how the Hon'ble Minister can say 'No'? Will he kindly make the position clear?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: The question is

not clear, Sir.

The Hon'ble the SPEAKER: What the hon. Member has urged is this: the petrol fund is from the taxes realised and as the expenditure was met from that fund, how do Government realise tolls which amounts to double taxation?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: The amount which was realised from petrol tax went to the central revenue, and this was Govern-

ment money, and no longer a tax paid by the people.

Mr. BAIDYANATH MOOKERJEÉ: The Hon'ble Minister most probably has not understood the question. My question is this: is it a fact that this bridge was built from the money received from the Central Government on account of petrol duty, being the share of the Assam Government. If that is a fact, Government cannot tax again in the shape of toll. The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: That is a matter

of argument, Sir.

Srijut ROHINI KUMAR CHAUDHURI: May I know if it is the policy of the Government to discontinue collection of tolls after the total cost has been realised?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: As I said the

question will be considered.

Srijut ROHINI KUMAR CHAUDHURI: I am not speaking with regard to this particular bridge. Is it the general policy of the Government?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I am not prepared

to answer that question now.

# Introduction of free Primary Education in the Province

\*2. Will Government be pleased to state-

(a) Whether they intend to introduce free primary education in the Province?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN replied:

2.(a) to (c)—Government are examining the report of the Primary Education Committee which has recommended introduction of free primary education and the proposal is under consideration.

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: The Committee was formed about three months back.

Mr. BAIDYANATH MOOKERJEE: May I know who are the members of

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: Mr. S. C. Roy, Retired I. E. S., Ex-D. P. I., Srijut Sarat Chandra Goswami, Retired Inspector of Schools and Maulavi Solman Chaudhury, Professor o Mathematics, Murarichand

Mr. BAIDYHNATH MOOKERJEE: When was the report submitted to

Government?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: Only last

month.

Mr. BAIDYANATH MOOKERJEE: May we have some idea as to how long it

will take to consider the report?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: The report is being printed now and as soon as the printed copies are available the report will be considered by Government. I hope very shortly we shall be able to come to some decision on this matter.

### Grant of allowance to Sreejukta Girija Bala Gupta

Mr. BAIDYANATH MOOKERJEE asked:

\*4. Will Government be pleased to state—

(a) Whether they have recently received any application from Sreejukta Girija Bala Gupta of Village Atgaon, P. O. Aloha, District Sylhet, praying for the grant of allowance on account of the detention of her elder brother and guardian Srijut Abala Kanta Gupta as a security prisoner in the Sylhet Jail?

(b) If so, what decision has been made in this matter?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA replied:

4.(a)—Yes.

(b)—Government see no reason to sanction a maintenance allowance as Srijut Abala Gupta has been released from detention.

Mr. BAIDYANATH MOOKERJEE: Has he been released unconditionally? The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: He has been asked to live within a certain limit.

Mr. BAIDYANATH MOOKERJEE: Is it a fact that he cannot see anybody

except the medical men and his relations?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: No, Sir, it is not a fact.

Babu DAKSHINARANJAN GUPTA CHAUDHURI: Is it not a fact that he

has been released on the ground of health?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: I need not give out the reasons why he has been released from detention, but he has been asked to live in his former place of habitation and as he was suffering from some disease in the jail he has been given every facility for medical treatment.

Mr. BAIDYANATH MOOKERJEE: Is it fact that he has been given per-

mission to proceed to Calcutta for medical treatment?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: If he wants to do so, that permission has been granted to him.

Mr BAIDYANATH MOOKERJEE: In that case how can he earn his live-

lihood? It is perfectly clear that he is very ill.

Babu DAKSHINARANJAN GUPTA CHAUDHURI: Is he in a position to

maintain his family?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: I don't know to which question I should reply, but in either case Government is satisfied that Mr. Gupta can maintain himself.

Babu KAMINI KUMAR SEN: Are Government satisfied that Mr. Abala

Gupta is ill?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: Surely, Government is not satisfied that Mr. Gupta should be ill.

Babu DAKSHINARANJAN Government CHAUDHURI: Are GUPTA satisfied that he is in a position to maintain somebody else?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: That is the

report we have got, Sir.

Mr. BAIDYANATH MOOKERJEE: From the answer the position is not quite clear. The reply is that as Mr. Abala Gupta has been released the question of giving assistance to his sister does not arise, because it necessarily follows that he will be in a position to earn money. Now, the Hon'ble Premier says that he is satisfied that though Mr Gupta is unwell and cannot work he can maintain his sister. These two statements are contradictory. Without taking advantage of my putting questions, will the Hon'ble Premier kindly let us know whether he is satisfied that the sister of Mr. Abala Gupta is really in straitened circumstances, and requires some relief from Government, since Mr. Gupta is under medical treatment and restrictions and cannot earn anything?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: The report is that Mr. Gupta is not bed-ridden, and he can carry on his normal avocation.

Therefore the question of separate maintenance for his sister does not arise.

Mr. BAIDYANATH MOOKERJEE: Will Government take it from me that the report is an entirely false one and Mr. Gupta is very ill and not at all fit to earn anything due to his health?

# Re Administration of Railway and Steamer Companies

Mr. BAIDYANATH MOOKERJEE asked:

\*5. Will Government be pleased to state— (a) Whether there is any representative of this Province in the Central Railway Board?

(b) If so, who is he?

\*6. (a) Are Government aware that, now-a-days, it takes at least 31 hours to reach Sylhet from Calcutta in place of 24 hours according to the arrangement prevalent in 1943, and that it causes hardship to the passengers? (b) If so, will Government be pleased to state what steps they have taken or

intend to take to remove this hardship? \*7. (a) Will Government be pleased to state whether they have got any voice or say in the administration of the Railways with regard to their timings or any other matter in so far as they relate to the Province of Assam?

(b) If so, what are they?

\*8. (a) Will Government be pleased to state whether they have any voice or say in the administration of Steamer Companies in so far it relates to this Province? (b) If so, what are they?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN replied:

5. (a)—No.

(b)—Does not arise.

Mr. BAIDYANATH MOOKERJEE: How (c) does not arise?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: In the Central Railway Board, as far as I know, there is no representation from the Provinces. The members are selected from the Central Legislative Assembly.

Mr. BAIDYANATH MOOKERJEE: Am I to understand that the Railway Authorities nominate their own members from the Members of the Central Legisla-

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I do not know

whether they are nominated or elected. Government make an enquiry Mr. BAIDYANATH MOOKERJEE: Will and see whether any representation from this Province can be secured in that Board? The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I am certain

there are no provincial representatives in that Board.

Mr. BAIDYANATH MOOKERJEE: Will Government take the initiative in securing one representation from this Province to that Board?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: The question may

be considered.

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN replied:

6. (a; & (b)—Government have no information, but if such is the case, this is obviously due to the abnormal conditions caused by the heavy military movements over which this Government have no control.

Mr. BAIDYANATH MOOKERJEE: Am I to understand that the Government is entirely satisfied, while using the word "obviously", that there is no other cause for

this delay except military movements?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: The hon. Member himself is a member of the Advisory Committee, and I think it is for him to bring this question before the Committee.

Mr. BAIDYANATH MOOKERJEE: In that case, let question No.7 be

answered now, Sir?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN replied:

7. (a) & (b)—The matters relating to administration of Railways are generally decided in the meetings of the Local Advisory Committee of Railways on which we have got our representatives from amongst the Members of the Provincial Legislature. Besides, sometimes matters like cancellation of Railway timings, closure of stations, etc., are decided by the Railway authorities in consultation with this Government. views of this Government are sometimes accepted and sometimes not.

Mr. BAIDYANATH MOOKERJEE: Sir, the reply is that the matters relating to the administration of Railways are decided in consultation with the members of the Advisory Committee. This is an entirely wrong information. I had the privilege of being a member of the Advisory Committee of both Assam-Bengal and Eastern Bengal Zones of the Bengal and Assam Railway and I dare say that the reply is not correct.

The Hon'ble the SPEAKER: The hon. Member is not to start a discussion, but

to put Questions.

Mr. BAIDYANATH MOOKERJEE: Sir, I am just explaining the remark of the Hon'ble Minister who said that I was in a better position to place the matter before the committee. He was entirely wrong to say that matters relating to administration of Railways are generally decided in the meetings of the Local Advisory Committee of The present-day meetings are farces.

Khan Bahadur Maulavi KERAMAT ALI: May I know from the hon. Questioner whether it is not a fact that timings are always placed before the Advisory Board

of which I had been a member before?

Mr. BAIDYANATH MOOKERJEE: It might have been the case when the hon. Member was a member of the Committee. But now-a-days the recommendations of the members of the Committee are not even taken into consideration, though most of them are vitally concerned with the travelling public,

Dr. C. G. TERRELL: Are Government aware that there are many other causes for dis-satisfaction with the Railway Administration, and that its incompetence even extends to inability to protect registered mail packages entrusted to its care from

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: Government have

no information.

Mr. BAIDYANATH MOOKERJEE: Will Government take it from me that considering the matter as it stands, Government have got some duty towards the civil population and that they should not shirk their responsibility on such unsound grounds?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I will point out to the hon. Members that there is the Economic Advisory Board; their duty is to review monthly the working of the Railways. The hon. Member is himself a member

Srijut ROHINI KUMAR CHAUDHURI: May I know from the Hon'ble Minister in how many instances the representations of the Government have been disThe Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: I cannot say Many a time Government representations have been disregarded.

†Srijut ROHINI KUMAR CHAUDHURI: May I know if any representation was made in the course of the last two years pointing out to the Railway authorities the inconvenience of the public?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: Only recently we represented this matter. Last time during the Budget Session when the inconveniences were brought to the notice of this House we had correspondence with the Railway authorities but to no effect.

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA replied:

9. (a)—The Deputy Commissioner externed him, being satisfied that his propagandist activities in this area were prejudicial to the peace.

(b)—He organized an office of the Kisan Sabha at Durlavcherra, but there is no evidence that he made any effort in the "Grow More Food Campaign".

(c) and (d)—Government are informed by the Deputy Commissioner that he can find nothing on record on these points.

(e) and (f)—Government see no reason to interfere. They are satisfied that the Deputy Commissioner would not have taken action against this individual, had his activities been healthy.

The Municipal Board was asked to apply for a loan from Government but they have not done so. It is for the Municipal Board to take initiative in this matter.

(b)—There are no minimum qualifications laid down.

(d)—Yes.

Maulavi MABARAK ALI: As regards (b), Sir, if no minimum qualification is fixed for filling up this highest post of the Education Department, then can anybody

and everybody be appointed as Director of Public Instruction?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: The post of Director of Public Instruction was formerly held by a member of the Indian Educational Service only. But since the retirement of Mr. S. C. Roy we have written to the Secretary of State to dereserve the post for the members of the Assam Educational So anyone and everyone cannot become Director of Public

Maulavi MABARAK ALI: -Sir, is it not necessary to fix the minimum qualifica-

tion for the post of Director of Public Instruction?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: No, Sir, it is not necessary; because only the members of the Assam Educational Service can aspire to become Director of Public Instruction and there is a minimum qualification laid down for recruitment to the Assam Educational Service.

†Srijut ROHINI KUMAR CHAUDHURI: Is not an under-graduate eligible for

this post?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN:—Probably not,

†Srijut ROHINI KUMAR CHAUDHURI :—If no under-graduate is eligible for this post, I may tell the Hon'ble Minister of Education that in the Assam Educational Service there is an Assistant Inspector of Schools who is not a graduate.

The Honble Khan Bahadur Maulavi SAYIDUR RAHMAN: I can assure House, Sir, that in the present cadre of this Service there is no under-

graduate.

†Khan Sahib Maulavi Dewan MUHAMMAD AHBAB CHAUDHURY: it not a fact, Sir, that the previous Director of Public Instruction, Mr. H. N. Sen was a member of the Assam Educational Service?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: Yes, Sir, he was. †Khan Sahib Maulavi Dewan MUHAMMAD AHBAB CHAUDHURY: If so, is not the present Director of Public Instruction entitled to hold the post of Director of Public Instruction who was previously a member of the same Educational Service?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: Yes, Sir,

he is.

†Srijut ROHINI KUMAR CHAUDHURI: Is it not a fact, Sir, that the present Assistant Inspector of Schools in the Assam Valley Circle is an under-graduate?

The Hon'ble the SPEAKER: This question does not arise out of the answers

given to the question about the post of Director of Public Instruction.

†Srijut ROHINI KUMAR CHAUDHURI: My hon. Friend the Minister-incharge has said that anybody from the Provincial Educational Service can be appointed and eligible for the post of Director of Public Instruction. But how is it that the present Assistant Inspector of Schools appointed by the present Hon'ble Minister of Education, is an under-graduate?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: The Assistant Inspector of Schools, Assam Valley Circle is in Class II of Assam Educational Service.

There is no under graduate in Class I of Assam Educational Service.

†Srijut ROHINI KUMAR CHAUDHURI: May I request the Hon'ble Minister of Education to lay down a minimum qualification for future entrants for the post of Director of Public Instruction?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: That will be done, Sir.

Maulavi MABARAK ALI: As regards (c) and (d), Sir, why was not the post

advertised?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN: It is a question of promotion, Sir.

### Appointment of Mass Literacy Officer

Maulavi MABARAK ALI asked:

\*18. Will Government be pleased to state—

(a) The special qualifications of Maulavi Abdul Gofur Chaudhury, Sub-Inspector of Schools, Sunamganj, for his being appointed as Mass Literacy Officer?

(b) Whether the said post was advertised before the appointment was made?

The Hon'ble Khan Bahadur Maulavi SAYIDUR RAHMAN replied:

18. (a;—He is a B. A., B. T. and Government considered him suitable for this post in view of his long experience and good record in the service. (b)—No.

## Replacement of retailers by Co-operative Stores

Maulavi MABARAK ALI asked:

\*19. Will Government be pleased to state whether it is a fact that order has recently been passed by Government to replace all retailers by Co-operative Stores for the supply of essential commodities to consumers?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA replied:

19.—No.

## Import of rice into Assam Valley

Maulavi MABARAK ALI asked: \*20. Will Government be pleased to refer to the Press Note, dated the 24th June 1944, to the effect "Thousands of tons of rice are in the course of despatch from North Bengal to Assam Valley......Government will continue to import rice to the detriment of the interests of cultivators and consumers alike, etc.", and be pleased to state-

(a) Whether this statement is correct? (b) If not, who are the persons or person responsible for making the statement?

(c) The action, if any, taken by Government against those persons?

(d) The actions, if any, taken by the Central Government or by the Bengal Government either directly or through Central Government against the Assam Government?

\*21. Will Government be pleased to state—

(a) Whether it is a fact that a notice to show cause why the contract for purchasing rice and paddy for the Government will not be cancelled, was recently issued upon the Surma Valley Rice Purchasing Syndicate?

(b) If so, whether the said Syndicate has submitted any explanation?

## The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA replied:

20.(a)—Yes, at the time it was made. (b) & (c)—Do not arise.

(d)—The Bengal Government issued a press note saying that it was not an export but only a loan.

†Mr. BAIDYANATH MOOKERJEE: As regards question No. 20, Sir, what was the correct position then, and the statement was made by whom-the Assam Govern-

ment or the Bengal Government?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: The correct position was that on account of the invasion of Assam by the Japanese army, people in the selling areas of rice became panicky and did not bring forward rice for sale, and as Assam Government required immediately sufficient supply of rice, we asked the Bengal Government to send us their surplus and allow that surplus to be exported to Assam which in due course would be paid by Assam.

† Mr. BAIDYANATH MOOKERJEE: The statement, as the reply goes, was made by the Bengal Government and that it was a case of loan. But so far as the Press Communique of our Government is concerned it was not a case of loan. My question is whether the Assam Government's statement is correct or that of the

Bengal Government?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: The position is, we asked for the surplus rice to be brought into our Province. It is not a case of import by Bengal, but import by Assam which the Bengal Government was to be paid. This Press note was issued at the time when final negotiation had not been reached with Bengal whether they would accept money or they were to be paid in kind.

Mr. BAIDYANATH MOOKERJEE: Did the Government contradict the defi-

nite statement that it was the case of a loan?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: It was definite

that it was a case of temporary loan.

†Mr. BAIDYANATH MOOKERJEE: But am I to understand that Bengal Government took advantage of it and tried to vilify our Government, Sir?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: No, Sir.

Maulavi MABARAK ALI: Is it not a fact that a surplus stock is still lying in the

Surma Valley Districts?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: Does the hon. Member mean the stock in the hands of the Government agents or the stock in the hands of the cultivators ! If the latter, it is 'yes'.

Babu RABINDRA NATH ADITYA: What was the attempt made by the Govern-

ment to get rice and paddy from the cultivators, Sir?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: The Assam Government's procurer of rice in the Assam Valley is Messrs. Steel Brothers. They have been operating since September 1942 and are purchasing all the surplus that is brought to the marketing centres by the cultivators or by the middlemen. They buy it, stock it and despatch to the places wherever required by the Army. As I mentioposition in certain areas at the time when the Press note was issued was that no rice and paddy came to the market and that the people did not like to sell their surplus of rice and paddy.

Babu RABINDRA NATH ADITYA: Was any attempt made to bring rice from stocks of the Surma Valley Agents to Assam Valley?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: We have been making many attempts to procure the entire surplus from the Surma Valley and supply it to the Army and to bring to the deficit areas in the Assam Valley but the Railway administration is standing in the way or rather the Regional Priority Committee who have the final say in arrangement of transport is vetoing this and no rice can be booked from the Surma Valley into Assam Valley through the Hill Section of the Railway. We have represented to the War Transport Department and the Food Department at Delhi.

Babu KAMINI KUMAR SEN: May I know, Sir, what was the idea when the Government of Assam approached the Government of Bengal for the supply of rice and whether they applied to the Bengal Government to get rice on purchase basis

or by way of loan? What was the original proposal?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: We simply asked the Bengal Government that the rice should immediately be made available, for it was required for Military consumption and the question whether it should be paid for, was left for subsequent negotiation.

Babu RABINDRA NATH ADITYA: What was the object of hurrying to the

Press with a statement at that time?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: In order to encourage people who hold surplus stock in the Assam Valley, to bring it to the market. If they held it back, we would be compelled to bring from outside.

Babu RABINDRA NATH ADITYA: Could it not be done earlier before the stock

was obtained from Bengal?

The Hon'ble Maulavi Saivid Sir MUHAMMAD SAADULLA: Our agents were procuring every day of the week and all on a sudden, the Japanese invasion of Naga Hills took place and the people became panicky and so they could not bring rice to the market.

†Mr. BAIDYANATH MOOKERJEE: Then was the Press note issued to

threaten the hoarders of the Assam Valley? Was that the idea?

The Hon'ble Maulavi Saiyid Sir MÚHAMMAD SAADULLA: It was to keep the morale of the people and to encourage them to use their surplus stock to best advantage.

†Mr. BAIDYANATH MOOKERJEE: Will Government be pleased to state whether they saw the editorial comments of several Newspapers of Calcutta regarding

this and blaming this Government? The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: Unless Mr. Mookerjee can give me the name of the papers and the editorials which appeared in the particular day I cannot answer that.

Babu KAMINI KUMAR SEN: Is it not a fact, Sir, that the Government of Bengal was asked to supply rice for Military necessity? The Hon'ble Maulavi Saiyid Sir MUHAMMÁD SAADULLA: It is perfectly

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA replied: correct, Sir.

21. (a)—Yes, on Messrs. E. B. & A. Commercial Syndicate.

†Mr. BAIDYANATH MOOKERJEE: May I know what was the reason for such

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: There was a an action? complaint that this Syndicate was taking over-weight from the people and not paying the actual price as notified by Government.

†Mr. BAIDYANATH MOOKERJEE: Sir, may I know what reply the Govern-

ment received from the Syndicate? The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: Sir, the Syndicate brought their explanation to show that the rice for which they had charged a higher rate to Government was purchased in December 1943, when the price was not fixed by the Assam Government. The whole matter was thoroughly gone into by myself and Ar. Marar and we allowed only a small sum of Rs. 30,000 on that account and we did not allow them to charge the higher rate for the quantity that was not

†Srijut ROHINI KUMAR CHAUDHURI: Is it not a fact, Sir, that rice sells in taken delivery in their godown in December.

Sylhet markets at a cheaper rate than the ordinary market rate? The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: My Friend has rather put the question in a rather distorted way. If his question is that rice is available in Sylhet market at a price lower than the controlled price fixed by the Government, the answer is 'Yes.

†Srijut ROHINI KUMAR CHAUDHURI: Do not the Goverment agents sell

at a price lower than the controlled rate? The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: The control price is for the consumer and the Syndicate purchases rice and paddy sometimes below that price.

Babu DAKSHINARANJAN GUPTA CHAUDHURI: Was the Government satisfied that the sellers were receiving a fairly reasonable price?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: So far as we

could see from the vouchers they did receive a fairly reasonable price.

Babu DAKSHINARANJAN GUPTA CHAUDHURI: Has any complaint reached the Hon'ble Premier or the Government with regard to the manipulation of these vouchers?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: Various rumours are afloat and I have received complaints in my last tour in the Sunamgani

area. I have taken up the matter in hand and it is under enquiry.

†Srijut ROHINI KUMAR CHAUDHURI: Is it a fact that the rice supplied through Government agents is sold at the controlled rate, whereas the rice not sold through Government agents is sold at a lesser rate than the controlled rate?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: Not so, Sir. †Maulavi MABARAK ALI: What was the charge against the Syndicate?

Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: That has already been replied. The charge was that they sold at a higher rate than at what they bought.

†Maulavi MARABAK ALI: May I know whether the matter was enquired into by Government?

The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: I have already replied to that.

every town has got two months' surplus stock. Babu RABINDRA NATH ADITYA: In our calculation of the monthly requirement of salt for Karimganj Subdivision and the Government supply of it, I find that The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: That may be the there is only one month's surplus there.

Babu DAKSHINA RANJAN GUPTA CHAUDHURI: What is the Government

policy in granting the quota of salt to each subdivision? The Hon'ble Maulavi Saiyid Sir MUHAMMAD SAADULLA: The Government policy is not merely to give the guaranteed quota but also to see that each subdivision has at least three months' stock in hand and on that basis they are importing salt at the rate of 1,35,000 maunds per month.

Babu RABINDRA NATH ADITYA: May I bring to the notice of Government that Karimganj Subdivision has been suffering much for want of salt and that it should

#### Condolence Motions

a letter of condolence to the bereaved family.

Srijut LAKSHESVAR BOROOAH: Mr. Speaker, Sir, I on behalf of the Party to which I have the honour to belong associate myself with what has been said by the Hon'ble Premier. Late Mr. Joges Chandra Gohain joined politics early in 1921 and since then he was an ardent Congress Member. In 1937 he was elected to this Assembly as a Congress Member and in 1941, for reasons of his own, he left the Congress Party and joined the Ahom group. As hon. Members know late Mr. Gohain was a man of amiable disposition and a perfect gentleman who took lively interest in all national causes both inside the Congress and outside. Sir, in

him Assam has lost a true patriot and Assam is really poorer to-day by his untimely death. Personally speaking, I have lost in him a true friend and his loss is a personal loss to me. One particular trait that impressed me most is this: Mr. Gohain acted in all circumstances according to his conscience. Whether he was a student or a public man he never hesitated to act as he thought fit. It is therefore no wonder that although he was a Congress man practically throughout his life, at one time, because he did not agree with the principles of the Congress Party, he resigned from that party. What he thought right he had stuck to that throughout without any fear of frown or favour. As I said he always acted according to his conscience.

Srijut SURENDRA NATH BURAGOHAIN: Mr. Speaker, Sir, I whole-heartedly associate myself with what has been said by the Hon'ble Premier regarding the demise of our hon. colleague Mr. Joges Chandra Gohain. Mr. Gohain died in harness. His was a career rare in many ways. He was a public man for quarter of a century and he had been a political sufferer.
