THE ASSAM LAND REVENUE RE-ASSESSMENT (AMENDMENT) ACT, 1986

> An Act

to amend the Assam Land Revenue Reassessment Act, 1936.

Whereas it is expedient to amend the Assam Land Revenue Re-assessment Act, 1936 (Assam Act VIII of 1936) hereinafter called the principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Thirty-Seventh Year of the Republic of India as follows:-

ment.

- Short title, 1. (1) This Act may be called extent and Land Revenue Re-assessment (Amendment) Act,

- (3) It shall come into force at once.

2. In the principal Act, after section 21, the of section 21 following shall be inserted as a new section 21A, of Assam Aet namely:— 1936.

> "21A. Notwithstanding anything contained in the foregoing provisions or in any contract or lease already issued under the provisions of this Act, State Govt. shall have the power to order re-settlement of all classes of land in any other local area under section 18 of the Assam Land Revenue and Regulation, 1886 if from a report prepared under section 6 of this Act, it is satisfied that re-settlement is necessary in the public interest before the expiry of the term of the existing lease."
