THE ASSAM CONTINGENCY FUND (AMENDMENT) ACT, 1984

Preamble.

Whereas it is expedient to amend the Assam Contingency Fund Act, 1950, hereinafter called the principal Act.

It is hereby enacted in the Thirty-fifth Year of the Republic of India as follows:-

- 1. (1) This Act may be called the Assam and com- Contingency Fund (Amendment) Act, 1984.
  - (2) It shall come into force at once and shall remain in force upto the 31st day of March, 1985.

- Amendment 2. In the principal Act, in Section 3, the of Section 3 following proviso shall be added, namely:—

  Act IX of 1950.
  - "Provided that during the period of operation of the Assam Contingency Fund (Amendment) Act, 1984, a further sum of fifteen crores of rupees shall be paid from and out of the Consolidated Fund of the State of Assam into the Contingency Fund."

Repeal and 3. (1) The Assam Contingency Fund (Amend-Assam Ordia ment) Ordinance, 1984 is hereby repealed.

(2) Notwithstanding such repeal anything done or any action taken under the Ordinance so repealed shall be deemed to have been done or taken under this Act as if this Act had commenced on the Twenty-eighth day of September, 1984 the date on which the said Ordinance came into force.
