**Proceedings of the First Session of the Assam Legislative Assembly
assembled after the first General Election under the Sovereign

Assam Non-Agricultural Urban Areas Tenancy Bill, 1950

Maulavi NAMWAR ALI BARBHUIYA asked :

2. (a) Will Government be pleased to state the fate of the Assam Non-Agricultural Urban Areas Tenancy Bill, 1950 passed by the Assam Legislative Assembly unanimously in its October, 1950 Session ?

(b) Is it a fact that the Attorney-General to the Government of India has raised some objections under section 19(f) of the Constitution ?

(c) If so, will Government be pleased to state what those objections are and what steps they have taken to meet those objections ?

(d) Was the Advocate General of Assam asked to give his views on the objections raised by the Attorney-General to the Government of India ?

(e) Will Government be pleased to state whether the Advocate-General of Assam was asked to give his opinion on the Bill before or at the time of its introduction in the House ?

(f) Are Government aware that this Bill was introduced on a persistent popular demand for it ?

(g) If so, will Government be pleased to state what steps they are contemplating to take in meeting this demand in view of these later developments ?

(h) Will Government be pleased to state the number of ejection suits filed in the different Civil Courts of the districts of Assam for ejecting tenants from urban areas (both in Munsiff's and Sub-Judges' Courts) for 3 years previous to the passing of the Assam Non-Agricultural Urban Areas Tenancy Bill in 1950 and the number of same class of ejection suits filed in different Civil Courts of the State, after Octobe , 1950, Subdivision by Subdivision ?

(i) Do Government propose to take steps for securing assent of the President of the Indian Republic to the Bill at a very early date ?

Shri HARESWAR DAS (Deputy Minister) replied :

2. (a)—The Bill in question was submitted to the Government of India for obtaining the assent of the President, but he has withheld his assent to it.

(b)—Yes.

(c)—The Attorney-General held that the provisions of clauses 4 and 9 and in part of clause 5 of the Bill offend against the fundamental right conferred on the land-lord by Article 19(1)(f) of the Constitution. The Bill has since been redrafted on the lines of Attorney-General's suggestions.

(d)—Yes. The Advocate General agreed with the views of the Attorney-General.

(e)—No. He was not consulted before introduction.

(f)—There were some representations requesting such legislation.

(g)—As stated above, the Bill has since been redrafted on the lines of the Attorney-General's suggestions and is being examined and if advised, will be placed before the House in due course.

(h)—The information is not available at the moment. It will however be collected and supplied to the hon. Member if he presses for it.

(i)—This will be done after the Assembly has passed the new Bill.

Government Resolution for giving a non-recurring grant of Rs.12,000 to the newly established Ram Krishna Mission Hospital at Laitumkhrah, Shillong

The Hon'ble Shri RUPNATH BRAHMA: Mr. Speaker, Sir, on the recommendation of His Excellency the Governor of Assam, I beg to move the following Resolution :—

"Whereas it becomes absolutely necessary for giving a non-recurring grant of Rs.12,000 (Rupees twelve thousand only) to the newly established Ram Krishna Mission Hospital at Laitumkhrah, Shillong during the last part of the financial year 1951-52 for the purchase of medicines and equipment and for its maintenance and whereas no provision was made in the Budget Estimates for 1951-52 for this purpose as the demand for the grant is unforeseen, it has been decided to give the grant of Rs.12,000 to the Ram Krishna Mission Hospital, Shillong from the balance amount of the grant of Rs.3,50,000 earmarked for giving grant-in-aid to Local Boards Dispensaries and Hospitals for high prices of medicine provided under the head '38—Medical—B—Hospitals and Dispensaries—(f)—Grants to Hospitals and Dispensaries—Grant for high prices of medicines' in the Budget for 1951-52".

Copies of this Resolution have already been forwarded to all hon. Members. As the approval of this House is necessary on the diversion of the amount—I therefore move that the diversion of the grant be approved by this House.

The Hon'ble the SPEAKER : Resolution moved :

Resolution re : formation of a Committee to make rules under Article 208(1) of the Constitution of India for regulating the procedure and conduct of business of the Assam Legislative Assembly

The Hon'ble Shri BISHNURAM MEDHI: Mr. Speaker, Sir, I beg to move : "That a Committee be formed consisting of the following hon. Members with the Hon'ble the Speaker as Chairman, to make rules under Article 208(1) of the Constitution of India for regulating the procedure and conduct of business of the Assam Legislative Assembly:—

- (1) Shri Purandar Sarma,
- (2) Shri Sarbeswar Barua,
- (3) Jonab Faiznur Ali,
- (4) Shri Hareswar Das,
- (5) Shri Hareswar Goswami,
- (6) Shri Hem Chandra Chakravarty, and
- (7) Shri Bimala Kanta Borah.

Three Members will form a quorum and the Committee to submit its report before the 30th September 1952.

"The Secretary to the Assembly will be the Secretary of the Committee".

Hon. Members will remember that with the inauguration of the new Constitution, the Rules then in force were adapted under Article 208(2) as an interim measure by the Hon'ble the Speaker as laid down in the Constitution. The Committee is formed to make rules under Article 208(1) which lays down—"A House of the Legislature of a State may make rules for regulating, subject to the provisions of this Constitution, its procedure and the conduct of its business". It is for the newly elected House to frame the rules under the new Constitution and this Committee is proposed for going into the matter and submit report to the House for consideration.

The Hon'ble Speaker however made some amendments and adaptations to bring in line under Article 208, sub-clause (2), which reads thus:

"Until rules are made under clause (1), the rules of procedure and standing orders in force immediately before the commencement of this Constitution with respect to the Legislature of the corresponding Province shall have effect in relation to the Legislature of the State subject to such modifications and adaptations as may be made therein by the Speaker of the Legislative Assembly, or the Chairman of the Legislative Council, as the case may be."

The Hon'ble Speaker made certain amendments under Article 208, sub-clause (2), and I now move for the formation of this Committee so that the House may take all these factors into consideration and make the modifications that are necessary under the Constitution. I therefore hope that the hon. Members will accept my Motion. After this Committee has submitted the report, it will be placed before the House for its consideration in detail.

The Hon'ble the SPEAKER: Have you anything to suggest? If not, I shall put the question.

(After a pause)

The question is :

Government Resolution re: approval of an expenditure of Rs.52,700 for implementing the "Key Village Farm Scheme"

The Hon'ble Shri MAHENDRA MOHAN CHOUDHURY: On the recommendation of His Excellency the Governor of Assam, I beg, Sir, to move the following Resolution :—

"That the Assembly do hereby approve the expenditure of Rs.52,700 for implementing the 'Key Village Farm Scheme' during the year ending 31st March 1952 as per Scheme below—

SCHEME

The Scheme is intended to be operated both in the General and Sixth Schedule (Part A) Areas but during the current year the operation will be confined to General areas only. It aims at improving the cattle of Assam by artificial insemination on the lines suggested by the Indian Council of Agricultural Research— $66\frac{2}{3}$ per cent. of the expenditure will be borne by the Central Government. The current year's expenditure of Rs.52,700 will be met from the savings under the service head '40.—Agriculture—D(II)—Intensive Cultivation (G.M.F.) Scheme—Prize Distribution Scheme'. The approval of the Assembly is, however, necessary as it is of the nature of a new service not contemplated in the Budget passed by the Assembly.

Presentation of the Rules framed under the Assam Primary Education Act, 1947

The Hon'ble Shri OMEO KUMAR DAS: Mr. Speaker, Sir, I beg to present the Rules framed under the Assam Primary Education Act, 1947.

The Assam Finance Bill, 1952

The Hon'ble Shri MOTIRAM BORA: Mr. Speaker, Sir, I beg to introduce the Assam Finance Bill, 1952, and to move that the Bill be taken into consideration.

The Hon'ble the SPEAKER: Motion moved is that the Assam Finance Bill, 1952 be taken into consideration.

Have you any comments to make ?

I put the question. The question is that the Assam Finance Bill, 1952 be taken into consideration.

(The Motion was adopted).

The Assam Opium Prohibition (Amendment) Bill, 1952

The Hon'ble Rev. J. J. M. NICHOLS-ROY: I beg to introduce the Assam Opium Prohibition (Amendment) Bill, 1952 ; and to move that the Bill be taken into consideration.

I do not think it is necessary to give any speech now. The Statement of Objects and Reasons shows the reason why we have brought forward this Bill before the House.

The Hon'ble the SPEAKER: Motion moved is that the Assam Opium Prohibition (Amendment) Bill, 1952 be taken into consideration.

I should like to request the Hon'ble Minister to give some idea about what it is, otherwise the Members seem to be in a fix as some of them are not well acquainted with the problem. If the Hon'ble Minister will give a little summary of the problem then it will help the hon. Members, otherwise some of them, probably being new to this House, will not be in a position to offer comments.

The Hon'ble Rev. J. J. M. NICHOLS-ROY: Sir, I shall be glad to give some information regarding this matter. It is stated in the Statement of Objects and Reasons that it has been found that the wordings in section 11(7) give scope for controversy as to whether this section is applicable to the proceedings under Section 16 of the Act and this point was recently argued in a case before the Hon'ble High Court, Assam. It is necessary that the provision should be made explicit to set at rest this controversy. The Bill seeks to do so.

I think it is necessary that I should give a little more information to the hon. Members of this House, and that is this. Section 11 of this Act deals with the security from habitual offenders to desist from committing offences. The Magistrate under this section has been allowed to issue an order to require a habitual offender who commits offences under section 5 or section 6 to show cause why he should not be ordered to execute a bond, with securities ; and certain procedure has been provided how to deal with such a person and how the enquiry should be made. After this, proceeding has been carried out by the Magistrate and enquiry has been made, order might be passed to execute a bond by the offender.

In sub-section (7) it is stated—

"For the purposes of this section, the fact that a person is a habitual offender within the meaning of sub-section (1) may be proved by evidence of general repute or otherwise."

This sub-section (7) of section 11 puts a limit to the application of this sub-section to an offender under Section 11. But Section 16 deals with the extermintion of habitual smugglers ; and it is contended by a leading Advocate in the High Court that there is a clear distinction between the subject matter dealt within Chapter V and that dealt within Chapter VI. Whereas Chapter V deals with a person's liability to execute a bond, Chapter VI deals with his liability to be extermited. The liability to be extermited is more serious than the liability to execute a bond. If it was the intention that the provision of sub-section (7) of section 11 of the Assam Opium Prohibition Act to be applied to the proceedings under section 16 in Chapter VI, it was wholly unnecessary to begin sub-section (7) of section 11 with the words—"for the purposes of this section" (i.e., section 11). If these words, "for the purposes of this section 11" had been omitted it might have been possible to contend that by reason of the words contained in section 17, Chapter VI, namely, "in so far as they are applicable" that this provision contained in sub-section (7) of section 11 as to hearsay evidence was also applicable to proceedings under

section 16 ; but so long as the limiting words, "for the purpose of this section" appear in sub-section (7) of section 11, there is no justification for extending it to proceedings under section 16. It is therefore desirable to set at rest the controversy. And in order to do so it is considered necessary to make the provision of sub-section (7) of section 11 applicable to proceedings under section 16 also by inserting the words "and section 16" after the words "for the purpose of this section." This Bill does that.

The Hon'ble the SPEAKER: The question is that the Assam Opium Prohibition (Amendment) Bill, 1952 be taken into consideration.

(The question was adopted.)

The Assam Maternity Benefit (Amendment) Bill, 1952

The Hon'ble the SPEAKER: The Hon'ble Shri Omeo Kumar Das to introduce Assam Maternity Benefit (Amendment) Bill, 1952.

In doing so, I would like to request the Hon'ble Minister to give some idea about this Bill, otherwise it may be difficult for hon. Members who are new to the House to appreciate the purpose of the amending Bill.

The Hon'ble Shri OMEO KUMAR DAS: Mr. Speaker, Sir, I beg to introduce the Assam Maternity Benefit (Amendment) Bill, 1952 ; and to move that the Bill be taken into consideration.

The House may remember that last year it adopted the amending Bill. But subsequently it was found that sub-sections (2) and (3) of section 4 of the amending Bill gave scope to various interpretations and therefore we are now seeking the permission of the House to bring this amending Bill. In sub-section (2) of section 4 the period of 12 weeks have been distributed to 4 weeks preceding delivery and 8 weeks after delivery and the word 'maximum' has been deleted because the word 'maximum' gave scope for different interpretation.

With these words, I beg to move that the Bill be taken into consideration.

The Hon'ble the SPEAKER: The Motion moved is that the Assam Maternity Benefit (Amendment) Bill, 1952, be taken into consideration.

(After a pause)

The question is :

"That the Assam Maternity Benefit (Amendment) Bill, 1952, be taken into consideration."

(The question was adopted.)

Discussion re introduction and consideration of certain Bills

The Hon'ble the SPEAKER: I should like to suggest that instead of the present practice of introducing a Bill and moving for consideration of the Bill on the same day, the Bill should be moved one day and on another date consideration of the Bill should be taken up, if this procedure suits the Government.

The Hon'ble Shri BAIDYANATH MOOKERJEE: Sir, both these Motions are moved on the same day because a separate date is allotted for consideration of the Bill clause by clause and on that date the hon. Members get sufficient time and opportunity to speak. Of course, when the Motion is moved for consideration, the hon. Members are at liberty to take part, but if they do not desire to speak anything at this stage they may do so on a future date when the Bill will be taken up for consideration clause by clause.

The Hon'ble Rev. J. J. M. NICHOLS-ROY: Dates for consideration of the Assam Opium Prohibition (Amendment) Bill and other Bills clause by clause have been fixed—29th and 31st March are the dates allotted for taking the Bill into consideration clause by clause. Now, I have moved the Bill to be taken into consideration.

The Hon'ble the SPEAKER: I quite appreciate and understand it.

Maulavi FAIZNUR ALI: Sir, it is the general practice that a Bill is first introduced by a Motion and then by another separate Motion the Bill is taken into consideration.

In the Motion for consideration, the hon. Members are required to discuss the general principles on which the Bill has been framed. So I submit that Motions for introduction and consideration should not be on the same date and combined into one Motion. The Bill should be introduced on a day and on another day it should be taken up for consideration when the hon. Members will be asked to take part in discussing the principles of the Bill.

The Hon'ble Shri BISHNURAM MEDHI: The convention is that at the stage for introductions and consideration of the Bill in case it is published in the Gazette and sent to the hon. Members, who had enough time to study the principles of the Bill, both the Motions for introduction and for consideration are taken in the same day. The principles can be discussed at the time when the Motion for consideration is moved. The introduction of the Bill at the same time is meant only to expedite matters and in that case of course the Bill will have to be published and distributed beforehand. But if the Bill is not published sufficiently earlier then only the argument advanced by Jonab Faiznur Ali is correct. After publication and distribution of the Bill sufficient time is available for hon. Member to offer suggestions at the stage of introduction. As a matter of fact, in cases of this nature the Bill is never opposed. The hon. Members have got copies of these Bills already and I think there cannot be any objection for consideration of the Bills. This is the convention and practice followed in this House. A new Committee is being formed for framing definite rules. The Committee will consider if any change of the existing practice and rule is needed.

The Hon'ble the SPEAKER: I entirely agree with Jonab Faiznur Ali and also with the Leader of the House. This question of procedure can be taken into consideration by the newly formed Committee for framing rules. The hon. Members can go through the Amendment and then place their suggestion; but we do not desire that there should be complete silence at the stage of consideration of the Bill. I shall also request the hon. Members of the Treasury Bench to give a detailed description of the Bill itself and its Amendments so that other hon. Members may follow it, as some of the Bills are of highly technical nature and therefore it is difficult to follow them in a short time. I trust this will be borne in mind. If you desire, the rules will be so amended

Shri JOGAKANTA BARUA: Sir, if we do not get the original Act how can we move amendment to it?

The Hon'ble the SPEAKER: The original Act is not supplied again along with the Amending Bill. If you want the original Act you are to go to the Assembly Library. After studying the original Act and then the Amending Bill you can come here prepared to offer your suggestion or amendment.

Maulavi FAIZNUR ALI: May I also draw your attention to Rule 59(a) ? After the Bill is introduced, the next motion will be that it be taken into consideration by the Assembly either at once or at some future day to be then mentioned.

The Hon'ble Shri BAIDYANATH MOOKERJEE: When a date is not mentioned at the time of moving a Motion it means that it should be taken up on that day.

The Hon'ble the SPEAKER: Not necessarily. But it is better that some future date be fixed for consideration and then to be taken up clause by clause. I entirely agree with Jonab Faiznur Ali.

The Hon'ble Shri BAIDYANATH MOOKERJEE: To clear up of my position may I add a word, Sir ? My point is this that if a Mover does not mention any future date and simply says that the Bill be taken into consideration, does it not mean that the Bill be taken into consideration on that very day ? Otherwise the Mover would have suggested a future date.

The Hon'ble the SPEAKER: That is the thing which is causing a little handicap to the hon. Members. The present procedure will go on till an amendment of this is made.

The Hon'ble Shri BISHNURAM MEDHI: Sir, may I draw your attention to the second Proviso of Rule 59 which runs as follows : "Provided further that no such motion shall be made until after copies of the Bill have been made available for the use of members, and that any member may object to any such motion being made unless copies of the Bill have been so available for seven days before the motion is made and such objection shall prevail unless the Speaker, in his discretion, allows the motion to be made". Now, copies of the Bill have been made available to the hon. Members and sent to them.

The Hon'ble the SPEAKER: The idea is that some hon. Members could have taken part in the consideration of the amendment, but now they are handicapped for one reason or another. The Government bench now seems to transgress this opportunity owing to the present rules. I may suggest for the benefit of the House that a little amendment in the present procedure be made, as suggested by hon. Maulavi Faiznur Ali Saheb.

The Hon'ble Rev. J. J. M. NICHOLS-ROY: May I suggest that hon. Members might not have taken part because the Bills are so simple ? (Laughter.)

The Hon'ble the SPEAKER: That is a good idea. But I consider it in a different way.

M. MOINUL HAQUE CHAUDHURY: The Bill may not be always so simple, Sir.

The Assam Tea Plantations Compulsory Savings Fund Scheme Bill, 1952

The Hon'ble the SPEAKER: Now the Hon'ble Shri Omeo Kumar Das is to introduce the Assam Tea Plantations Compulsory Savings Fund Scheme Bill, 1952, and to move that the Bill be taken into consideration. I hope the Hon'ble Shri Omeo Kumar Das will give a little detail about this, if it is possible.

The Hon'ble Shri OMEO KUMAR DAS: Mr. Speaker, Sir, I beg to introduce the Assam Tea Plantations Compulsory Savings Fund Scheme Bill, 1952. The Bill has already been published in the Gazette and it was laid on the

table on the 8th of March last. From the Statement of Objects and Reasons, it will be clear to the House why we propose to introduce the Bill. Having considered the advice tendered by the Minimum Wages Committee, which was set up by Government, Government have now fixed the minimum wage which will come into force from the 30th March next. We now propose to take measures so that the labourers with their increased earnings may not waste their cash earnings. The House is aware of the condition of the plantation labourers; how backward they are, how illiterate and how ignorant they are and how low their standard of living is. The plantation labour is generally imported from distant places in the up countries. The House is aware of their food habits. Last year, when the Government introduced the All-India ration scale, there was much resentment against this introduction and there was a tendency on the part of the labourer to go to the neighbouring markets and purchase more rice, at exorbitant prices. The House may be aware that the plantation labour is accustomed to the in-take of cereal rations to the extent of twenty-five oz. per day. The objective for which the All-India ration scale was sought to be introduced would be frustrated if the plantation labour is given the opportunity to go to the neighbouring markets to satisfy his increased needs of cereals. Moreover this Bill is introduced with the object to train plantation labour in thrift habits and thus to improve his economic condition. There has been much criticism elsewhere outside this House regarding this Savings Scheme, but having read all these criticisms, I have come to the conclusion that the critics have approached the question from an academic standpoint and not from a realistic point. The labourer will have to be saved from wasting his increased earnings in purchasing liquor and other intoxicant. Besides the savings scheme will also stabilise the economic condition of the country.

With these words, Sir, I introduce this Bill and move that the Bill be taken into consideration.

The Hon'ble the SPEAKER: I find some difficulty—in introducing and considering the Bill at the same time. I find that what I have suggested, the Hon'ble Members in the Treasury Benches found it difficult to follow; they are not in a position to change the convention.

Maulavi FAIZNUR ALI: Introduction is one Motion and taking into consideration is another Motion. The usual practice may be that the Bill has been introduced and then may pass on to the next Motion.

The Hon'ble Shri BAIDYANATH MOOKERJEE: You can correct us, Sir.

The Hon'ble the SPEAKER: I do not want to put the Treasury Benches into difficulty.

The Motion moved is that the Assam Tea Plantations Compulsory Savings Fund Scheme Bill, 1952 be introduced.

(The Motion was put as a question and adopted.)

The Hon'ble Shri OMEO KUMAR DAS: We can take the second Motion now, Sir.

I beg to move that the Assam Tea Plantations Compulsory Savings Fund Scheme Bill, 1952 be taken into consideration.

The Hon'ble the SPEAKER: The Motion moved is that the Assam Tea Plantations Compulsory Savings Fund Scheme Bill, 1952 be taken into consideration.

(The Motion was then put and adopted.)

Adjournment

The Assembly was then adjourned till 10 A.M. on Thursday, the 20th March, 1952.
